We have reviewed the accompanying statement of unaudited standalone financial statements of Jawaharlal Nehru Port Trust ("JNPT") for the six month period ended as on March 31, 2020. The Preparation of Financial Statements is the Responsibility of JNPT's management and has been placed before the Bond Committee of JNPT. Our Responsibility is to issue a report on these financial statements based on our review.

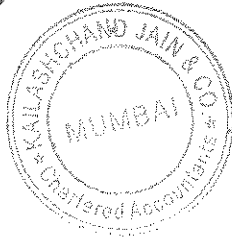
