LOCAL NOTICE TO MARINERS NO. 06/2022

- Sub: 1. Maintenance Dredging of the entire Mumbai Port & JN Port Navigation Channel by Dredging Corporation of India (DCI).
2. Capital Dredging of BMCTPL Phase-II

1. The Maintenance Dredging of the entire Mumbai Port and JN Port Navigation Channel from Section A to F for the year 2022-2023 has commenced w.e.f. 04-11-2022. The crafts proposed to be deployed for survey/dredging works are survey Boats ME Queen, TSHD 'Antigoon' WID 'ASL Bulan', and work boat 'MT Arshiya'.

2. Capital Dredging of BMCTPL Phase-II berth pocket has commenced from October, 2022 & will continue till March, 2023. The details of crafts which will be involved in capital dredging are TSHD Volvox Olympila, TSHD Volvox Aisa, Bed Levellen Antareja, Survey Boats Aero Express. Force & work Boar SB8M2. Additionally, a list of crafts are attached.

3. All these crafts will be manning VHF Channel 12, 13 & 16. The TSHD's & self propelled harbour barges will be dumping the dredged spoil material in Dumping Station (DS-3). The coordinates of which are given below:

All mariners are hereby advised to take note of the above while passing the Dredgers in the channel. The local fishing community is hereby advised to not to lay their nets in the Anchorage areas and Navigation Channel/Maneuvering areas of JN Port (as highlighted in the copy enclosed).
