**Sub: Common code for DPD agencies – Regarding.**

As a part of simplification of procedure for implementing DPD, it is felt prudent to have common code in all Terminals operating under JNPT against each Agency availing DPD facility.

Please note that 3 digit alpha numeric common codes have been created by JNPT and the same will be followed by all Terminals against DPD codes issued prior to 01.04.2018. There will be no change in DPD codes issued from 01.04.2018 onwards (as alpha numeric common codes are being issued by JNPT w.e.f. 01.04.2018 and the same is adopted by all Terminals).

Complete list of DPD agencies with common code along with corresponding DPD code and IEC number is displayed on JNPT website [www.jnport.gov.in](http://www.jnport.gov.in) under 'Direct Port Delivery' at sr. no. 22 (link : [http://jnport.gov.in/Direct\\_port.aspx](http://jnport.gov.in/Direct_port.aspx)).

All Importers and Shipping lines are requested to use these common codes w.e.f. 24.09.2018 (in respect of vessels berthing from 24.09.2018 onwards at JNPT). However, there will be no change in User ID and pass words of PIN system (Import E-Form 13) currently being adopted.

This will come in to force w.e.f. 24.09.2018.
