Sub: Discounts in VRC & CRC for handling of containers/cargo from/to Shahid Beheshti Port, Chabahar.

This has reference to Trade Notice dtd. 24.10.2020 issued by JNPT extending following benefits to the shipping lines for cargo to be handled at Shahid Beheshti Port, Chabahar subject to compliance of conditions stipulated in the attached S.O.P:

- a. JNPT extends 40% discount on Vessel Related Charges (VRC) for all Terminals (except berth hire in case of NSIGT/BMCTPL) on proportionate basis subject to loading of minimum 50 TUEs/5000 MT (exports) on a vessel for handling container/cargo from/to Shahid Beheshti Port, Chabahar and 40% discount on Cargo Related Charges (CRC) for the containers (Import and exports) handled at JNPCT for Shahid Beheshti Port, Chabahar.
- b. NSIGT/BMCT extends 40% discount on berth hire charges also (part of VRC) on proportionate basis subject to loading of minimum 50 TUEs/5000 MT (exports) on a vessel for handling container/cargo from/to Shahid Beheshti Port, Chabahar.
- c. NSIGT/BMCTPL extends 40% discount on Cargo Related Charges (CRC) for the containers (Import and exports) handled for Shahid Beheshti Port, Chabahar.
- d. GTI also extends 40% discount on Cargo Related Charges (CRC) in case they handle containers (imports and exports) in future for Shahid Beheshti Port, Chabahar since currently they cannot handle containers to/from Chabahar as per Trade restrictions.

In line with directives of Ministry, the above benefits are now extended for another one-year period w.e.f 24.10.2020. The SOP indicated in the Trade Notice dtd. 24.10.2019 will remain same.
