**SUB: SUPPLEMENTARY AGREEMENT NO:2 FOR INTER -TERMINAL RAIL HANDLING OPERATION (ITRHO) AT JNPA.**

**Date:** 30/11/2023

A Supplementary Agreement no:2 for Inter-Terminal Rail Handling Operation Agreement was signed on 30<sup>th</sup> November, 2023 between all the Port Terminals including the new Terminals Nhava Sheva FreePort Terminal (NSFT) and Nhava Sheva Distribution Terminal Pvt. Ltd (NSDTPL).

As per the supplementary agreement no:2, the existing ITRHO charges of Rs.400/- per TEU will be increased to Rs.800/- per TEU. The new rate will be applicable from 1<sup>st</sup> January, 2024.

There will be an escalation every year @60% of the variation in Wholesale Price Index (WPI) announced by Government of India occurring between 1st January to 31st December of the previous year which will be effective from 1<sup>st</sup> May, 2025.
