Subject – Fuel Adjustment Cost (FAC) to be billed in the month of July 2025

Reference – Maharashtra Electricity Regulatory Commission (Multi Year Tariff) Regulations, 2019

As per MERC MYT Regulations, 2019 and further amended time to time, Fuel Adjustment Charge (FAC) is applicable every month in electricity bill of the consumer. Accordingly, FAC to be levied to the consumers of JNPA Distribution Licensee in the billing of July 2025 is as follows –
