Sir,

JNPA had invited above subject tender online from 29.11.2025 to 27.12.2025 and bid submission date was 27.12.2025. Technical Bid of your firm was opened on 29.12.2025 at 1530 hrs. You had submitted bid online for subject work and also submitted a Bank Guarantee against EMD as per tender requirement. On verification of the submitted bank guarantee with the issuing bank, the Bank vide its letter dated 23.01.2026 and email dated 31.01.2026 have informed that submitted Bank Guarantee is fake and mismatched.

As per NIT clause 1.4 of tender document, non-submission of the original financial instruments towards cost of Tender document and EMD within the tender submission period leads to disqualification of bids. Accordingly, your bid stands technically disqualified for non-submission of valid Bank Guarantee against EMD. Accordingly, the show cause notice was issued on 04.03.2026 to you for seeking explanation as to why you should not be blacklisted. Till date no response is received from your side.

In view of this it has been decided to ban the business dealings with you and you are hereby debarred from entering into contracts with JNPA and with the authorities partnering with JNPA for a period of two years.

a) This order shall have been following effects :

- i. Further business dealing with your firm is banned with immediate effect i.e. 30.03.2026. The order banning would operate for the period of 02 years. Competent authority may extend the period of banning.

- ii. Within the period of banning, no business dealing shall be held with you firm No Enquiry/ Bid/Tender shall be issued to your firm nor will the bids submitted by your firm be entertained.
- b) Your firm shall not be allowed to participated as joint venture/ sub-vendor/sub-contractor in the Tenders.

Further, if your firm is an approved sub-vender under any contract for such equipment/component/service, the main contractor shall not be permitted to place work order/ Purchase Order/ contract on your agency as as such-vendor/sub-contractor after the date of Banning even though the name of the party has been approved as a sub-vendor/Sub-contractor earlier.

- c) Banning of Business dealings shall not be applicable to the subsidiary company of the banned Agency provided subsidiary company has not participated on the strength of the banned Agency. However, in case of a default by a sub-contractor, the banning shall be applicable to the sub-contractor as well as the Lead Partner of the concerned JV or the sole bidder as the case may be.

On expiry of the above period of banning, you may approach JNPA with a request for revocation of the order mentioning inter-alia the steps taken by you to avoid recurrence of misconduct which has led to Banning.
