TRADE NOTICE

Sub: Barging operations for non-hazardous cargoes and Bunkering at JNPT.

Based on the requests of PSU oil companies like BPCL, IOCL and HPCL to supply bunker fuel at Anchorage / berths and to implement the circular No. JNP/OPRN-BT/LIQUID/2010/798/1428 dated 22/09/2010 to allow barging operations for non-hazardous cargoes such as Edible oil, Lube oil, Molasses etc. at JNPT to meet the requirement of shipping lines and Importers / Exporters to overcome congestion, the competent authority has decided the following :-

- To allow the barging operations at Liquid cargo Jetty for loading / discharging of non-hazardous cargoes subject to availability of the space alongside berths after berthing of normal vessels at LB-I and LB-II.
- To allow overside operations from the vessel into the self propelled barges at Liquid Cargo Jetty and then into the Tank Lorries at SWB-I / II.
- To allow the barges for overside operations at JNPT inner anchorage from the vessel and then into the Tank Lorries at SWB-I / II or at Liquid cargo Jetty through pipeline into the Tankfarm subject to availability of the space alongside berths after berthing of normal vessels at LB-I and LB-II.
- To allow the barges at anchorage / berths for discharging / loading the bunkers from the vessel / storage tanks (inside and outside the port area) subject to availability of the space alongside berths after berthing of normal vessels at LB-I / II and SWB-I / II.
- To allow the barges alongside the vessel to supply the bunker at any berth including the container berths after taking customary fire precautions.

This Trade notice will come into force with immediate effect.
