Subject: Submission of vessel related Documents by the shipping lines, tank farms, and CHAs etc. for Berthing of vessel at BPCL Liquid Cargo Jetty, JNPT....reg.

To streamline the berthing of the vessels, it is reconfirmed that the liquid cargo vessels will be berthing on priority and first-cum-first-serve norms issued vide circular No. JNP/OPRN-CM (O)/LIQUID/2010/137 Dtd 01/02/2010.

- However, an arrived vessel shall be considered to be ready when all the documents submitted up to 16:30 Hrs on the previous day for readiness of the vessel. Any document submitted after 16:30 Hrs on previous day to 10:30 Hrs on the day of daily pre-berthing meeting will be accepted at Bulk Terminal office only and not in the daily pre-berthing meeting. Moreover, the documents submitted during the aforesaid period will not be considered towards readiness of the vessels in the daily preberthing meeting held at 10:30 Hrs but will be considered for the next day's daily pre-berthing meeting.
- In order to have a win-win situation, the priority vessels may be considered for providing priority berthing on the date of priority if the vessel arrives prior to 10:30 hrs of the daily pre-berthing meeting subject to readiness of the vessel and availability of the berth, failing which will be considered in the next day's pre-berthing meeting if the vessel arrives as per the norms for berthing of liquid cargo vessels on priority and firstcum-first-serve basis issued vide circular No. JNP/OPRN-CM (O)/LIQUID/2010/137 dtd. 01/02/2010 (Refer Sr.No. (a)4 for priority berthing).
- The format of 12 Hrs priority undertaking attached at Annex. -I need to be submitted prior to 12 Hrs priority berthing.
- In order to overcome the clashing date of priority, the Port will adopt practical approach to accept priority dates of PSU vessels keeping reasonable time to handle a non-priority vessel in between two priority vessels as per existing berthing norms.
