Jawaharlal Nehru Port Authority issued the trade notice dated 26<sup>th</sup> July 2024, which had provided for the toll rates with validity period from 01<sup>st</sup> Aug 2024 to 31<sup>st</sup> Oct 2024, with below toll rate.
