Sub: Implementation of Enhanced MSW-Sagar Setu Modules

Following information has been received from IPA (Indian Port Association):

“As per guidelines issued by Indian Port Association (IPA) on **21.11.2025, 04.12.2025, and 24.12.2025**, along with the subsequent stakeholder consultations held in this regard for Enhanced MSW-Sagar Setu Modules (Vessel Profile and Voyage Registration).

In continuation thereof, this is to inform that, the **enhanced modules of the Maritime Single Window (MSW) – Sagar Setu platform** (<https://nlpmarine.gov.in>) have now been **successfully implemented** and are proposed to be **made operational with effect from 07 January 2026**.

The revised modules have been developed in alignment with the **International Maritime Organisation (IMO) Facilitation of International Maritime Traffic (FAL) Convention** and the Government of India's “**One Nation, One Port Process (ONOP)**” initiative. The key enhancements implemented include:

- **Vessel Profile Module**, comprising structured sections on:
 - o Vessel Basic Information
 - o Vessel Technical Information
 - o Vessel Certificates
- **Voyage Registration Module**, incorporating standardised workflows covering:
 - o Voyage Details
 - o Cargo Details
 - o Crew List
 - o Passenger List
 - o Ship Stores Declaration
 - o Dangerous Goods
 - o Security Details

These enhancements are intended to **streamline business processes, minimise data redundancy, and improve data standardisation and interoperability** across ports and regulatory stakeholders.

All stakeholders are requested to **inform the relevant users within their Ports/Organisations** about the above implementation and ensure readiness for operational usage from the effective date. Any observations, issues, feedback or suggestions arising during usage may kindly be shared with IPA at monu.joon@ipa.org.in for review and further necessary action.


