As per "Stevedoring and Shore handling Policy for Major Ports-2016, issued Ministry of Shipping, Govt. of India, TAMP has notified ceiling tariff for "Stevedoring and Shore handling operations" for Break Bulk/General cargo at JNPT

The "STEVEDORING AND SHORE HANDLING POLICY- 2016, JNPT" and the TAMP notified ceiling tariff for" Stevedoring and Shore handling services" is available on JNPT website. The list of registered firms for Stevedoring and Shore Handling operations will be uploaded on the JNPT website.

The licensee shall not charge higher than the TAMP notified ceiling rates for Stevedoring and Shore handling activities in Port.

The licensee shall a pay to JNPT, a Royalty of Rs.20/- per Metric Ton of cargo handled, for the stevedoring and shore handling operations. GST at prevailing rates will be applicable for the Royalty.

Henceforth, only those agencies will be permitted to perform the stevedoring and shore handling operations who are issued valid license for this purpose by JNPT.

This will be come in to force from 1st December 2019.
