Sub: Charges for Handling of DPD Containers at JNPCT.

Attention of all the Importers, Shipping lines/Agents and all other stakeholders is invited to the order passed by Tariff Authority of Major Ports (TAMP) on 16th May 2017 and further notified in the Gazette of India Extraordinary (Published in Part –III Section 4 of the Gazette of India, Extraordinary) on 31/05/2017 vide Gazette No. 223.

On the basis, Port intends to collect DPD Charges from Importers registered for DPD for delivery of Import DPD containers from JNPCT as indicated below:

Port will also collect Dwell time charges, if any, for the DPD containers from Importers directly as per TAMP approved tariff.

All Importers need to open a PD account with JNPT and maintain Minimum balance depending upon the basis of average fortnightly handling of containers by Importers as per details given below:

All payments are to be made through PCS in advance. PCS registration of many importers is already completed by PCS team and username and password along with user guide is sent to the registered mail ids of importers from mail id support.ipcs@nic.in. If not received, you can contact PCS support on same mail id or mobile no. 9910716769 or toll free number 1800 115 055.

In case your agency is not registered in PCS, then you need to register at Port Community System (PCS) under link stake holder registration on website: www.indianpcs.gov.in. For system/PCS related issues with JNPT, you may contact on 6781 5180 or ctcctech@jnport.com.

In case amount of PD account goes below minimum balance as indicated above, the Import E-Form 13 (PIN system) account will be deactivated and importer will not be able to allocate containers or generate PINs for containers for DPD delivery. To avoid deactivation of accounts, importers shall ensure that sufficient balance in PD account is always maintained and all necessary payments towards DPD charges or any other charges are to be made 3 days in advance before arrival of such containers.

In case account is deactivated, then you need to recoup the sufficient amount and contact JNPT Finance section for activation of the same on 022-6781 4107 or 022-6781 4548 or through mail finrevet@jnport.gov.in.

Accordingly, all DPD Importers are requested to open PD account and deposit minimum balance amount (as indicated above) latest by 14th of September 2017 and abide with above procedure to ensure smooth delivery of DPD containers from Terminal

The above DPD charges will be applicable w.e.f 15th September 2017.
