### TRADE NOTICE

Tariff Authority for Major Ports Vide its order dated 04<sup>th</sup> January 2017 revised scale of rates vide Notification No. TAMP/48/2016-JNPT dated 10<sup>th</sup> January 2017 providing increase in Marine related charges/Cargo related charges and other certain miscellaneous tariff item. The details of revised scale of rate is available as Annex of the Notification issued by TAMP and hosted by TAMP on their website [www.tariffauthority.gov.in](http://www.tariffauthority.gov.in).

However Port will now collect only revised Vessel Related charges along with indexation charge as per TAMP approved Order. The new rate will come into effect from 01<sup>st</sup> June 2017.

It is to clarify that since the revised rate will come into effect from midnight of 31st May 2017, all vessels which are berthed upto 2400 hrs of 31st May shall attract Port Dues and Pilotage at old rates and for berth hire beyond 2400 hrs on 31st May 2017, new rate will apply since it is on hourly basis. In case a vessel arrives on 29<sup>th</sup> or 30<sup>th</sup> May 2017 and stays beyond 31st May 2017, berth hire for actual number of hours upto 2400 hrs of 31st May will be levied at old rate and thereafter at new rates.
