MUC COLLECTION NOTIFICATION FOR BHARAT MUMBAI CONTAINER TERMINAL Notice No.: JNP/CM(F)/Public Notice/2018/ Date: 31/03/2018

The Tariff authority at Major Ports (TAMP) has authorized JNPT to collect the Mandatory User Charges (MUC) of Rs. 145/- (Excluding GST) for the FY 2018-2019 for all the containers entering and exiting the five terminals of JNPT including the newly started terminal at JNPT i.e. Bharat Mumbai Container Terminal Private Limited (BMCTPL) for the Logistics Data Bank (LDB) Project, vide its order dated 29th October, 2014 (Case No. TAMP/49/2014-JNPT), which was notified in the Gazette of India on 14th November, 2014 vide Gazette No.328 read with its speaking order dated 13th February , 2015.

A SPV namely "DMICDC Logistics Data Services Limited" (DLDSL) has been formed between National Industrial Corridor Development and Implementation Trust (NICDIT) and NEC Corporation, Japan to provide the LDB service.

Logistics Data Bank will provide the service of tracking the containers on near real-time basis using the Radio Frequency Identification (RFID) Technology while containers are being transported through railways and trucks on major highways through its portal www.ldb.co.in. The LDB service coverage would commence at BMCTPL from 1st April 2018.

The MUC will be collected for all the containers entering and exiting from all the five terminals including the newly started container terminal which is Bharat Mumbai Container Terminal Limited (BMCTPL) of JNPT at the rate mentioned above.

The MUC will not be applicable for transshipment and coastal containers.
