Sub: Provisional Revision of Estate Related Tariff w.e.f. 1st August 2025

The validity of Estate Related Tariff as approved by TAMP vide Order dated 1st June 2020 published in Gazette No.252 dated 3rd July 2020 will expire on 31st July 2025.

In view of the same, with the approval of Competent Authority, JNPA Estate related Tariff are revised provisionally w.e.f. 1st August 2025 as per Policy Guidelines for Land Management, 2015 as follows :

Charges for Advertisement

The Fee for advertisement hoarding and signage shall be calculated as per the following method:

- **Total License Fee = Area of Hoarding X (Base License fee X All applicable premiums)**
- In case of Hoarding/ Signage on Public Property/ JNPA land, the Ground Rent shall be added to the Total License Fee.
- The Development Permission Scrutiny Fee shall be payable over and above the License fee for processing of the application for hoarding/ signage in JNPA SEZ
- The Security Deposit shall be payable by the applicant, prior to installation of the signage.

Other Conditions:

- For Large, Medium and Small Format Advertisement, ground rent shall be charged on the basis of display area of the advertisement as per the Lease Rental of JNPA land as per Estate Scale of Rates of JNPA published in State Gazette with annual escalation of 2% p.a.
- Ground rent will not be applicable to Advertising on moving transit and Advertisement on shops
- A person/company applying for permission to advertise within JNPA shall pay scrutiny fees of Rs.16/per Sq.Mtr or part thereof with minimum of Rs.1000.
- A person/company applying for permission to advertise shall also pay interest free Security Deposit of 6 months of total applicable fee. The same shall be forfeited if conditions pertaining to permission for advertising are not fulfilled. Security Deposit will be refunded without interest at end of license fee period. No Security Deposit will be payable for hoarding on leased plots.
