Subject : Partial modification to Circular No. A/PE/A/14/2026/344 dated 06.04.2026 regarding filling up of the post of Deputy General Manager (Traffic) in the pay scale of ₹80,000-₹2,20,000 in JNPA through absorption under the Composite Method - reg.

In partial modification of this office Circular No. A/PE/A/14/2026/344 dated 06.04.2026 on the subject cited above, it is hereby clarified and informed as under:

1. Consideration of Earlier Applications :

Applications already submitted by eligible candidates in response to the Vacancy Circular Ref. No. A/PE/A-10/2025/81/534 dated 30.06.2025 for filling up the post of Deputy General Manager (Traffic) in Jawaharlal Nehru Port Authority through absorption under the Composite Method shall be treated as valid for the present selection process. Such candidates are not required to submit fresh applications.

2. Submission of Updated Clearances :

Notwithstanding the above, all such candidates who have applied against the vacancy circular no. A/P/E/A-10/2025/81/534 dated 30.06.2025, shall mandatorily submit updated Administration Clearance and Vigilance Clearance, duly issued by the Competent Authority of their parent organization, on or before 06.05.2026, for consideration of their candidature in the current selection process. Failure to submit the said clearances shall render the candidature liable to be excluded from further consideration.

3. Fresh Applications by New Candidates :

Candidates who have not applied earlier in response to the Vacancy Circular dated 30.06.2025 may submit their applications afresh in accordance with the provisions contained in Circular No. A/PE/A/14/2026/344 dated 06.04.2026, along with all requisite documents, through proper channel.
