TRADE NOTICE

Sub: Waiver of 50% Ground Rent on Import-laden Containers accruing ground rent beyond 8 days — applicable for containers discharged on or after 01.05.2026 and removed before 2400 hrs on 20.06.2026.

Due to a shortage of trailer drivers during April–May 2026, CFSs and DPD importers were unable to evacuate import containers in a timely manner, causing inventory build-up and extended container dwell inside port terminals.

In recognition of the hardship caused to importers — though the responsibility for evacuation rests with CFSs and factory/business owners — JNPA has decided to offer the following relief:

Parameter	Detail
Relief	50% reimbursement of ground rent paid from 9th day of landing onwards
Eligible containers	Import Laden containers bound for CFS or DPD by road, unloaded from ship on or after 07:00 hrs on 01.05.2026 and gated out on or before 24:00 on 20.06.2026
Must be removed from Terminal	On or before 24:00 hrs on 20.06.2026
Not eligible	Containers landed after 24:00 hrs on 12.06.2026

Claim Process:

Importers must submit ground rent payment invoices with details to identify the container, copy of the DO and their bank details to the office of GM Finance, JNPA. Upon verification of eligibility, 50% of ground rent accrued from Day 9 of landing till removal will be reimbursed directly to the importer.

This Notice is issued with the approval of the Competent Authority of JNPA.
